**RECOMMENDING THE AWARD OF CONTRACT TO ANLEO MAINTENANCE & ALLIED SERVICES  
FOR THE RADOME CLEANING FOR DAVAO GRS**

**WHEREAS**, the Solutions and Services Engineering Division submitted to the Bids and Awards Committee (BAC) Purchase Request No. GAA-21-03-10998 for the Radome Cleaning for Davao GRS (**Annex “A”**) with an Approved Budget for the Contract (ABC) amounting to Sixty Thousand Pesos Only (₱60,000.00) which was included in the Supplemental Annual Procurement Plan (APP) No. 5 for Fiscal Year 2021 (**Annex “B”**).

**WHEREAS**, the mode of procurement is based on Item No. 8, Annex “H” of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, which provides that the Procuring Entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed One Million Pesos (₱1,000,000.00);

**WHEREAS**, on 07 April 2021, the BAC published the Request for Quotation (RFQ) (**Annex “C”**) and invited three (3) suppliers of known qualifications to participate in said procurement, namely: (1) Anleo Maintenance and Allied Services.; (2) Montaverde General Cleaning Services.; and (3) Aquakleini Cleaning Services;

**WHEREAS**, the End-user forwarded to the BAC Secretariat its evaluation (**Annex “D”**) which found the offer of Anleo Maintenance and Allied Services compliant with the eligibility requirements and specifications, which was verified by the BAC. Its quotation, with a total amount of Sixty Thousand Pesos Only (₱60,000.00), inclusive of all government taxes and fees, is deemed the most advantageous to the government, thereby making the same as the Single Calculated Responsive Quotation;

**WHEREAS**, the BAC finds the recommendation of the End-user in compliance with RA No. 9184 and its 2016 revised IRR; and

**WHEREAS**, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

**NOW, THEREFORE**, for and in consideration of the foregoing, **WE**, the Members of the BAC, hereby **RECOMMEND** to the HoPE the following:

- 1) **AWARD OF CONTRACT** via Small Value Procurement to **ANLEO MAINTENANCE AND ALLIED SERVICES** for the **RADOME CLEANING FOR DAVAO GRS** in the amount of **SIXTY THOUSAND PESOS ONLY (₱60,000.00)**, inclusive of all appropriate taxes and fees; and
- 2) **APPROVAL** of the foregoing result/s.
