WHEREAS, the Solutions and Engineering Division submitted to the Bids and Awards Committee (BAC) Purchase Request No. GRASPED-20-09-10228 for the Supply and Delivery of Toolset for Antenna Maintenance and Other Items (**Annex “A”**) with an Approved Budget for the Contract (ABC) amounting to One Hundred Eight Thousand One Hundred Pesos Only (₱128,100.00) which was included in the Supplemental Annual Procurement Plan (APP) No. 17 & 21 for Fiscal Year 2020 (**Annex “B”**);

WHEREAS, the mode of procurement is based on Item No. 8, Annex “H” of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, which provides that the Procuring Entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed One Million Pesos (₱1,000,000.00);

WHEREAS, on 05 November 2020, the BAC published the Request for Quotation (RFQ) (**Annex “C”**) and invited three (3) suppliers of known qualifications to participate in said procurement, namely: (1) Jassen Harris Industries Corp.; (2) Ace Electronic Technology, Inc.; and (3) Ulytech Trading.;

WHEREAS, the End-user forwarded to the BAC Secretariat its evaluation (**Annex “D”**) which found the offer of Jassen Harris Industries Corp. compliant with the eligibility requirements and specifications. Its quotation, with a total amount of **One Hundred Ten Thousand Pesos Only (₱110,000.00)**, inclusive of all government taxes and fees, is deemed the most advantageous to the government, thereby making the same as the Single Calculated Responsive Quotation;

WHEREAS, the BAC finds the recommendation of the End-user in compliance with RA No. 9184 and its 2016 Revised IRR; and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity or his/her duly authorized representative.

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the Members of the BAC, hereby **RECOMMEND** to the Head of Procuring Entity the following:

- 1) **AWARD OF CONTRACT** via Small Value Procurement to **JASSEN HARRIS INDUSTRIES CORP.** for the **SUPPLY AND DELIVERY OF TOOLSET FOR ANTENNA MAINTENANCE AND OTHER ITEMS** in the amount of **ONE HUNDRED TEN THOUSAND PESOS ONLY (P110,000.00)**, inclusive of all appropriate taxes and fees; and
- 2) **APPROVAL** of the foregoing result/s.
