For 2.20 of the technical specifications, winning bidder should provide a clear-channel layer 2 point to point link, without any layer 3 routing elements along the network path Can we provide or deliver link that is clear channel but is over layer 3? (Layer 2 over layer 3)	·
For Lots 1 and 2, do they have the same site A and B?	Different point Bs: Lot 1 is in DICT Office in Cebu (Information and Communications Technology Office, Toll Center, Port Area, Aduana St. Cebu City) while Lot 2 is in a private data center in Cebu (ASTI IC Node, Asiatown IT Park, Apas, Jose Maria St., Cebu City)

If Lots 1 and 2 are already installed, can we proceed with the billing already while waiting for other lots to get com- pleted?	Yes, as these items are not dependent / bundled with one another. Billing starts upon the acceptance of link as reflected in 1.4 and 2.23.
Given that we have five (5) lots for the project, can you confirm that the provider must only provide single Eligibility and Financial Bid Documents? Then we will just state in the Financial Documents the lots we are going to bid?	Yes, if you will bid for the five (5) lots, only one eligibility and financial documents are needed.
Whose ASN will be put in the required ND to be submitted?	It's the provider's.
Is site survey required? If yes, do we have site inspection certificate need to be submitted?	Ocular inspection is not required; however, provider must give evidence that the area is serviceable.
For Lot 2, is Site address B is an ASTI office - ASTI IC Node, Asiatown IT Park, Apas Jose Maria St., Cebu City?	No, it's a private data center (Globe's/Innove's).
It was mentioned that it requires bundled collocation/two (2) full rack, collocation specs are out of control of any bidder except for the owner of the DC, for this case is Globe. Does this mean the set up will be the winning bidder will order collocation to Globe and ASTI will use it?	prevent service downtime.
Are these five (5) circuits existing? May we know who the existing provider is/are?	Except for Lot 2 (ASTI to CB1), its existing provider is Globe / Innove. For Lot 2, it is a new procurement.
For the delivery of items, is it okay that we will outsource to a third-party provider that will provide the local loop? For example, if we will outsource it with PLDT just to provide the local loop but the contracting party is still with ASTI and Eastern.
