**RECOMMENDING THE AWARD OF CONTRACT TO ZIONEYES GENERAL MERCHANDISE
FOR THE SUPPLY AND DELIVERY OF ONE (1) LOT VARIOUS PROMOTIONAL
MATERIALS**

WHEREAS, the Knowledge Management Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) **Purchase Request No. HR Lite-24-03-18899** for the **Supply and Delivery of One (1) Lot Various Promotional Materials** which was included in the **DOST-ASTI Annual Procurement Plan No. 3 and No. 6 for Fiscal Year 2024**;

WHEREAS, with an Approved Budget for the Contract (ABC) amounting to **Three Hundred Thirty-Five Thousand Nine Hundred Forty Pesos Only (₱335,940.00)**, the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on **04 April 2024**, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to three (3) suppliers of known qualifications, viz: (1) Zioneyes General Merchandise; (2) Tanjer Enterprise; and (3) Dart Printing Services;

WHEREAS, before the lapse of the deadline for submission of quotations on **08 April 2024, 2:00 PM**, six (6) bidders submitted their respective quotations, particularly: (1) **Tanjer Enterprises**; (2) **JDR Trading Services**; (3) **Dart Printing Services**; (4) **Zioneyes General Merchandise**; (5) **Berachah Advertising Services**; (6) **VJ Graphic Arts, Inc.**;

WHEREAS, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by **Zioneyes General Merchandise** it was evidenced that said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by **Zioneyes General Merchandise** in the amount of **Two Hundred Twenty-Five Thousand Pesos Only (₱225,000.00)** inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirement;

WHEREAS, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offer of **Zioneyes General Merchandise** compliant with the technical requirements;

WHEREAS, **Zioneyes General Merchandise** was determined to be the bidder with **Lowest Calculated Responsive Quotation**; and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

WHEREFORE, the DOST-ASTI BAC RESOLVES, as it is hereby RESOLVED, to recommend to the DOST-ASTI HoPE, for his approval, to award the contract for the SUPPLY AND DELIVERY OF ONE (1) LOT VARIOUS PROMOTIONAL MATERIALS through NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT), to ZIONEYES GENERAL MERCHANDISE with a total bid amount of TWO HUNDRED TWENTY-FIVE THOUSAND PESOS ONLY (P225,000.00) inclusive of all government taxes and fees.
