RECOMMENDING THE AWARD OF CONTRACT TO VARIOUS SUPPLIERS FOR THE SUPPLY AND DELIVERY OF SIX (6) LOTS VEHICLE RENTAL AND OTHER ITEMS

WHEREAS, the Research and Development Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) **Purchase Request No. ROAMER-24-10-20167** for the **Supply and Delivery of Six (6) Lots Vehicle Rental and Other Items** which was included in the **DOST-ASTI Annual Procurement Plan No. 20 for Fiscal Year 2024** The procurement opportunity is broken down into the following items:

WHEREAS, with an Approved Budget for the Contract (ABC) amounting to **One Hundred Twenty-Six Thousand Five Hundred Pesos Only (₱126,500.00)**, the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on **29 October 2024**, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to three (3) suppliers of known qualifications, viz: (1) Maria Ave Rent-A-Car; (2) MIB Rent-A-Car; and (3) CCM Car Rental and Allied Services;

WHEREAS, before the lapse of the deadline for submission of quotations on **04 November 2024, 2:00 PM**, two (2) bidders submitted quotations, particularly: (1) **Maria Ave Rent-A-Car** and (2) **7SQ OPC**;

WHEREAS, the End-user forwarded to the BAC Secretariat its evaluation, which found that a tie occurred between two (2) bidders, particularly, **7SQ OPC** and **Maria Ave Rent-A-Car**. The breakdown of their tied quotations is as follows:

WHEREAS, Section 3.3. of Government Procurement Policy Board (GPPB) Circular 06-2005 dated 05 August 2005 provides that:

“However, in lieu of the pre-determined criteria set and declared in the bidding documents, the procuring entity may opt to bring the concerned bidders to agree on a better selection

criteria which should also be nondiscretionary/non-discriminatory and is similarly based on sheer luck or chance”.

WHEREAS, on 06 November 2024, the DOST-ASTI BAC conducted the tie-breaking activity pursuant to the above Circular, in which **7SQ OPC** won the said activity;

WHEREAS, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by **7SQ OPC** and **Maria Ave Rent-A-Car**, it was evidenced that said prospective bidders complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposals submitted by **7SQ OPC** and **Maria Ave Rent-A-Car** in the amounts of **Seventy-Two Thousand Six Hundred Fifteen Pesos Only (₱72,615.00)** and **Forty-Eight Thousand Seven Hundred Pesos Only (₱48,700.00)** respectively, inclusive of all government taxes and fees, are within the ABC and, thus, compliant with the financial requirements;

WHEREAS, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offers of **7SQ OPC** and **Maria Ave Rent-A-Car** compliant with the technical requirements;

WHEREAS, **7SQ OPC** and **Maria Ave Rent-A-Car** were determined to be the bidders with **Lowest Calculated Responsive Quotations**; and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

WHEREFORE, the **DOST-ASTI BAC RESOLVES**, as it is hereby **RESOLVED**, to recommend to the **DOST-ASTI HoPE**, for his approval, the following:

- 1) To award the contract for the **SUPPLY AND DELIVERY OF SIX (6) LOTS VEHICLE RENTAL AND ONE (1) LOT VEHICLE RENTAL** through **NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT)**, to **7SQ OPC** with a total bid amount of **SEVENTY-TWO THOUSAND SIX HUNDRED FIFTEEN PESOS ONLY (₱72,615.00)**, inclusive of all government taxes and fees; *and*

- 2) To award the contract for the **SUPPLY AND DELIVERY OF THREE (3) LOTS VEHICLE RENTAL AND ONE (1) LOT VEHICLE RENTAL** through **NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT)**, to **MARIA AVE RENT-A-CAR** with a total bid amount of **FORTY-EIGHT THOUSAND SEVEN HUNDRED PESOS ONLY (₱48,700.00)**, inclusive of all government taxes and fees.
