RECOMMENDING THE AWARD OF CONTRACT TO GEMSTONE ENTERPRISE FOR THE SUPPLY AND DELIVERY OF MOBILE PEDESTAL

WHEREAS, the Finance and Administrative Division and Computer Software Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) **Purchase Request Nos. GAA-24-09-19904 and QCS-24-10-20087** for the **Supply and Delivery of Mobile Pedestal**, which was included in the **DOST-ASTI Annual Procurement Plan for Common-use Supplies and Equipment No. 6 and 11 for Fiscal Year 2024**. The procurement opportunity is broken down into the following items:

WHEREAS, with an Approved Budget for the Contract (ABC) amounting to **One Hundred Twenty-Nine Thousand Pesos Only (₱129,000.00)**, the mode of procurement is pursuant to Section 52 (b) (Shopping) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on **10 October 2024**, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to five (5) suppliers of known qualifications, viz: (1) *Gemstone Enterprise*; (2) *Peniton Trading*; (3) *Adcor Non-Specialized Whole Sale Trading*; (4) *Magneto Enterprise*; and (5) *Design Crest Furniture Component*;

WHEREAS, before the lapse of the deadline for submission of quotations on **14 October 2024, 2:00 PM**, four (4) bidders submitted quotations, particularly: (1) *Gemstone Enterprise*; (2) *ROSHQ Trading*; (3) *Suntawood Home & Office Inc.*; and (4) *Office Republic Multi-ventures, Inc.*;

WHEREAS, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by **Gemstone Enterprise** it was evidenced that the said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by **Gemstone Enterprise** in the amount of **Seventy-Six Thousand One Hundred Sixty-Four Pesos Only (₱76,164.00)**, inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirements;

WHEREAS, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offer of **Gemstone Enterprise** compliant with the technical requirements;

WHEREAS, **Gemstone Enterprise** was determined to be the bidder with **Lowest Calculated Responsive Quotation**; and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

WHEREFORE, the **DOST-ASTI BAC RESOLVES**, as it is hereby **RESOLVED**, to recommend to the **DOST-ASTI HoPE**, for his approval, to award the contract for the **SUPPLY AND DELIVERY OF MOBILE PEDESTAL** through **NEGOTIATED PROCUREMENT UNDER SECTION 53 (b) (SHOPPING)**, to **GEMSTONE**

ENTERPRISE with a total bid amount of **SEVENTY-SIX THOUSAND ONE HUNDRED SIXTY-FOUR PESOS ONLY (₱76,164.00)**, inclusive of all government taxes and fees;
