**RECOMMENDING THE AWARD OF CONTRACT TO ZIONEYES GENERAL MERCHANDISE FOR THE SUPPLY AND DELIVERY OF TWO HUNDRED (200) PIECE AUTOMATIC UMBRELLA WITH LOGO AND TEXT**

**WHEREAS**, the Computer Software Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) **Purchase Request No. GAA-24-11-20258** for the **Supply and Delivery of Two Hundred (200) Pieces Automatic Umbrella with Logo and Text** which was included in the **DOST-ASTI Annual Procurement Plan No. 20 for Fiscal Year 2024**;

**WHEREAS**, with an Approved Budget for the Contract (ABC) amounting to **Seventy-Six Thousand Pesos Only (₱76,000.00)**, the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

**WHEREAS**, on **14 November 2024**, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to three (3) suppliers of known qualifications, viz: (1) Zioneeyes General Merchandise; (2) MPC; and (3) JDR Trading Services;

**WHEREAS**, before the lapse of the deadline for submission of quotations on **18 November 2024, 2:00 PM**, four (4) bidders submitted quotations, particularly: (1) **Metro Promo Concepts Corp.**; (2) **Zioneeyes General Merchandise**; (3) **D.E. Linens and Textile Trading**; and (4) **Titus118 Non Specialized Wholesale Trading**;

**WHEREAS**, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by **Zioneeyes General Merchandise** it was evidenced that said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by **Zioneeyes General Merchandise** in the amount of **Seventy-One Thousand Six Hundred Pesos Only (₱71,600.00)**, inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirement;

**WHEREAS**, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offer of **Zioneeyes General Merchandise** compliant with the technical requirements;

**WHEREAS**, **Zioneeyes General Merchandise** was determined to be the bidder with **Lowest Calculated Responsive Quotation**; and

**WHEREAS**, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

**WHEREFORE, the DOST-ASTI BAC RESOLVES, as it is hereby RESOLVED, to recommend to the DOST-ASTI HoPE, for his approval, to award the contract for the SUPPLY AND DELIVERY OF TWO HUNDRED (200) PIECES AUTOMATIC UMBRELLA WITH LOGO AND TEXT through NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT), to ZIONEYES GENERAL MERCHANDISE with a total bid amount of SEVENTY-ONE THOUSAND SIX HUNDRED PESOS ONLY (₱71,600.00), inclusive of all government taxes and fees.**
