## ASTI – BIDS AND AWARDS COMMITTEE BAC Resolution No. 25-01-004

RECOMMENDING THE AWARD OF CONTRACT TO THE PLAZA GARDEN HOTEL & RESIDENCES CORP. FOR THE PROCUREMENT OF ONE (1) LOT LEASE OF VENUE FOR DOST-ASTI 2024 PERFORMANCE ASSESSMENT AND PLANNING FOR 2025-2026

WHEREAS, the Office of the Director submitted to the DOST-ASTI Bids and Awards Committee (BAC) Purchase Request No. GAA-25-01-20533 for the Lease of Venue for DOST-ASTI 2024 Performance Assessment and Planning for 2025 - 2026 and shall be undertaken through Section 53.10 (Lease of Venue) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, the Lease of Venue shall be conducted within Baguio on 29-31 January 2025 (tentative schedule), with an Approved Budget for the Contract (ABC) amounting to Three Hundred Sixty Thousand Two Hundred Forty-Nine Pesos and 34/100 Only (\$\frac{1}{2}\$360,249.34);

**WHEREAS**, it is preferred that government agencies lease publicly-owned real property or venue from other government agencies. However, in a Memorandum dated **14 January 2025**, the end-user unit justified that leasing a privately-owned venue is more advantageous than leasing a government-owned venue. Likewise, in support of its position, the end-user unit conducted market research and submitted a cost-benefit analysis;

**WHEREAS**, the Consolidated Guidelines for the Alternative Methods of Procurement, item V-D 9(c)(ii)(a) of Annex "H" in the 2016 revised IRR of RA No. 9184 provides that "the BAC shall send the RFQ to at least three (3) venues within the vicinity of the selected location. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof";

**WHEREAS**, on 17 January 2025, the DOST-ASTI BAC, through its Secretariat initiated the procurement activity by publishing a Request for Quotation (RFQ) and inviting three (3) prospective lessors, namely: (1) The Plaza Garden Hotel and Residences Corp.; (2) Baguio Burnham Suites; and (3) Venus Parkview Hotel;

WHEREAS, before the deadline for submission of quotation on 20 January 2025, 2:00 PM, two (2) bidders submitted quotations, *viz*: (1) The Plaza Garden Hotel and Residences Corp.; and (2) Venus Parkview Hotel;

WHEREAS, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by the prospective lessor, it was evidenced that The Plaza Garden Hotel and Residences Corp. complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by The Plaza Garden Hotel and Residences Corp. in the amount of Three Hundred Two Thousand Four Hundred Pesos Only (₱302,400.00), inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirement;

**WHEREAS**, the venue being offered by **The Plaza Garden Hotel and Residences Corp.** was rated by the end-user unit in accordance with the technical specifications prepared pursuant to Appendix B (Rating Factors and Determination of Reasonableness of Rental Rates) of the Consolidated Guidelines for the Alternative Methods of Procurement, as follows:

WHEREFORE, the DOST-ASTI BAC RESOLVES, as it is hereby RESOLVED, to recommend to the DOST-ASTI HoPE, for his approval, to award the contract for the LEASE OF VENUE FOR DOST-ASTI 2024 PERFORMANCE ASSESSMENT AND PLANNING FOR 2025 - 2026, through NEGOTIATED PROCUREMENT UNDER SECTION 53.10 LEASE OF REAL PROPERTY AND VENUE, to THE PLAZA GARDEN HOTEL AND RESIDENCES CORP., with a total bid amount of THREE HUNDRED TWO THOUSAND FOUR HUNDRED PESOS ONLY (₱302,400.00), inclusive of all government taxes and fees.
