**RECOMMENDING THE AWARD OF CONTRACT TO AMO CHARTERED BUSES & CARS
OPERATION SERVICES FOR THE SUPPLY AND DELIVERY OF ONE (1) LOT VEHICLE RENTAL
FOR THE PARTICIPANTS OF THE DOST-ASTI 2024 PERFORMANCE ASSESSMENT AND
PLANNING FOR 2025-2026**

WHEREAS, the Office of the Director submitted to the DOST-ASTI Bids and Awards Committee (BAC) **Purchase Request No. GAA-25-01-20534** for the **Supply and Delivery of One (1) Lot Vehicle Rental for the Participants of the DOST-ASTI 2024 Performance Assessment and Planning for 2025-2026** which was included in the **DOST-ASTI Annual Procurement Plan No. 1 for Fiscal Year 2025**;

WHEREAS, with an Approved Budget for the Contract (ABC) amounting to **One Hundred Forty-Five Thousand Pesos Only (₱145,000.00)**, the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on **18 January 2025**, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to three (3) suppliers of known qualifications, viz: (1) AMO Chartered Buses and Cars Operation Services; (2) 3RLFD Transport Services; and (3) Victory Liner;

WHEREAS, before the lapse of the deadline for submission of quotations on **21 January 2025, 2:00 PM**, only one (1) bidder submitted a quotation, particularly **(1) AMO Chartered Buses and Cars Operation Services**;

WHEREAS, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by **AMO Chartered Buses and Cars Operation Services** it was evidenced that said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by **AMO Chartered Buses and Cars Operation Services** in the amount of **One Hundred Forty-Five Thousand Pesos Only (₱145,000.00)** inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirement;

WHEREAS, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offer of **AMO Chartered Buses and Cars Operation Services** compliant with the technical requirements;

WHEREAS, **AMO Chartered Buses and Cars Operation Services** was determined to be the bidder with **Single Calculated Responsive Quotation**; and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

WHEREFORE, the DOST-ASTI BAC RESOLVES, as it is hereby RESOLVED, to recommend to the DOST-ASTI HoPE, for his approval, to award the contract for the SUPPLY AND DELIVERY OF ONE (1) LOT VEHICLE RENTAL FOR THE PARTICIPANTS OF THE DOST-ASTI 2024 PERFORMANCE ASSESSMENT AND PLANNING FOR 2025-2026 through NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT), to AMO CHARTERED BUSES AND CARS OPERATION SERVICES with a total bid amount of ONE HUNDRED FORTY-FIVE THOUSAND PESOS ONLY (₱145,000.00), inclusive of all government taxes and fees.
