RECOMMENDING THE AWARD OF CONTRACT TO VARIOUS SUPPLIERS FOR THE SUPPLY AND DELIVERY OF TWENTY-TWO (22) UNITS OF HEADPHONES AND OTHER ITEMS

WHEREAS, the Solutions and Services Engineering Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) **Purchase Request No. GAA-23-06-16912** for the **Supply and Delivery of Twenty-Two (22) Units of Headphones and Other Items**, which was included in the **DOST-ASTI Annual Procurement Plan Common Supplies and Equipment Nos. 3 & 12 for Fiscal Year 2023**. The procurement opportunity is broken down into the following items:

WHEREAS, with an Approved Budget for the Contract (ABC) amounting to **One Hundred Fifty-Four Thousand Fifty-Eight Pesos Only (₱154,058.00)**, the mode of procurement is pursuant to Section 52 (b) (Shopping) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on 10 June 2023, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to five (5) suppliers of known qualifications, viz: (1) Jassen Harris Industries Corp.; (2) ArtJohnley Enterprises; (3) Uly Tech Trading; (4) Gophertech Corporation; and (5) Maitilink Systems Inc.;

WHEREAS, before the lapse of the deadline for submission of quotations on 14 June 2023, 2:00 PM, five (5) bidders submitted quotations, particularly: (1) **Jassen Harris Industries Corp.**; (2) **ArtJohnley Enterprises**; (3) **JDR Trading Services**; (4) **Primetek International Non-Specialized Wholesale Trading**; and (5) **Ban Bee Commercial Co., Inc.**;

WHEREAS, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by **Jassen Harris Industries Corp.** and **Ban Bee Commercial Co., Inc.**, it was evidenced that **Jassen Harris Industries Corp.** and **Ban Bee Commercial Co., Inc.** complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposals submitted by **Jassen Harris Industries Corp.** and **Ban Bee Commercial Co., Inc.**, in the amount of **Twenty-Nine Thousand Eight Hundred Pesos Only (₱29,800.00)** and **Seventy-Two Thousand One Hundred Sixty Pesos Only (₱72,160.00)**, inclusive of all government taxes and fees, are within the ABC and, thus, compliant with the financial requirements;

WHEREAS, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offers of **Jassen Harris Industries Corp.** and **Ban Bee Commercial Co., Inc.** compliant with the technical requirements;

WHEREAS, **Jassen Harris Industries Corp.** and **Ban Bee Commercial Co., Inc.** were determined to be the bidder with **Lowest Calculated Responsive Quotations**; and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

WHEREFORE, the **DOST-ASTI BAC RESOLVES**, as it is hereby **RESOLVED**, to recommend to the **DOST-ASTI HoPE**, for his approval, the following items:

- (1) To award the contract for the **SUPPLY AND DELIVERY OF TWENTY-TWO (22) UNITS OF HEADPHONES**, through **NEGOTIATED PROCUREMENT UNDER SECTION 53 (b) (SHOPPING)**, to **BAN BEE COMMERCIAL CO., INC.** with a total bid amount of **SEVENTY-TWO THOUSAND ONE HUNDRED SIXTY PESOS ONLY (₱72,160.00)**, inclusive of all government taxes and fees; and
- (2) To award the contract for the **SUPPLY AND DELIVERY OF TWO (2) UNITS OF PORTABLE SPEAKER**, through **NEGOTIATED PROCUREMENT UNDER SECTION 53 (b) (SHOPPING)**, to **JASSEN HARRIS INDUSTRIES CORP.** with a total bid amount of **TWENTY-NINE THOUSAND EIGHT HUNDRED PESOS ONLY (₱29,800.00)**, inclusive of all government taxes and fees.
