**RECOMMENDING THE AWARD OF CONTRACT TO TRIBES LIGHTS AND SOUND RENTAL FOR THE SUPPLY AND DELIVERY OF ONE (1) LOT MULTIMEDIA RENTAL FOR PROGRAM WIDE CONGRESS**

**WHEREAS**, the Computer Software Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) **Purchase Request No. ALAM-25-01-20538** for the **Supply and Delivery of One (1) Lot Multimedia Rental for Program Wide Congress** which was included in the **DOST-ASTI Annual Procurement Plan No. 1 for Fiscal Year 2025**;

**WHEREAS**, with an Approved Budget for the Contract (ABC) amounting to **Seventy-Five Thousand Pesos Only (₱75,000.00)**, the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

**WHEREAS**, on **17 January 2025**, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to three (3) suppliers of known qualifications, viz: (1) Tribes Lights and Sound Rental; (2) SRR Audio Lights and Sounds; and (3) Showimage;

**WHEREAS**, before the lapse of the deadline for submission of quotations on **20 January 2025, 2:00 PM**, only one (1) bidder submitted a quotation, particularly **(1) Tribes Lights and Sound Rental**;

**WHEREAS**, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by **Tribes Lights and Sound Rental** it was evidenced that said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by **Tribes Lights and Sound Rental** in the amount of **Seventy-Five Thousand Pesos Only (₱75,000.00)** inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirement;

**WHEREAS**, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offer of **Tribes Lights and Sound Rental** compliant with the technical requirements;

**WHEREAS**, **Tribes Lights and Sound Rental** was determined to be the bidder with **Single Calculated Responsive Quotation**; and

**WHEREAS**, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

**WHEREFORE**, the **DOST-ASTI BAC RESOLVES**, as it is hereby **RESOLVED**, to recommend to the **DOST-ASTI HoPE**, for his approval, to award the contract for the **SUPPLY AND DELIVERY OF ONE (1) LOT MULTIMEDIA RENTAL FOR PROGRAM WIDE CONGRESS** through **NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT)**, to **TRIBES LIGHTS**

**AND SOUND RENTAL** with a total bid amount of **SEVENTY-FIVE THOUSAND PESOS ONLY (₱75,000.00)**, inclusive of all government taxes and fees.
