WHEREAS, the Computer Software Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) Purchase Request No. ALAM-25-01-20506 for the Supply and Delivery of Sixty (60) Pieces Polo Shirt (Embroidered) and Other Items which was included in the DOST-ASTI Annual Procurement Plan No. 1 & 2 for Fiscal Year 2025. The procurement opportunity is broken down into the following items:

WHEREAS, with an Approved Budget for the Contract (ABC) amounting to One Hundred Fifteen Thousand Seven Hundred Pesos Only (₱115,700.00), the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184:

WHEREAS, on 06 February 2025, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to four (4) suppliers of known qualifications, viz: (1) DOT/ ON&IT Fine Embroider / IBYK-Kurt Printing Services.; (2) Giftbox Handy Crafts; (3) Kingtian Pros Advertising; and (4) AVECOM General Merchandise;

WHEREAS, before the lapse of the deadline for submission of quotations on 10 February 2025, 2:00 PM. three (3) bidders submitted their respective quotations, particularly: (1) Light Energy Enterprise; (2) Zioneyes General Merchandise; and (3) Giftbox Handy Crafts;

WHEREAS, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by Light Energy Enterprise and Zioneyes General Merchandise it was evidenced that said prospective bidders complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposals submitted by Light Energy Enterprise and Zioneyes General Merchandise in the amounts of Fourteen Thousand Pesos Only (₱14,000.00) and Eighty-One Thousand Five Hundred Seventy-Five Pesos Only (₱81,575.00) respectively, inclusive of all government taxes and fees, are within the ABC and, thus, compliant with the financial requirement;

WHEREAS, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offers of Light Energy Enterprise and Zioneyes General Merchandise compliant with the technical requirements;

WHEREAS, Light Energy Enterprise and Zioneyes General Merchandise were determined to be the bidders with Lowest Calculated Responsive Quotations; and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.
