WHEREAS, the Finance and Administrative Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) **Purchase Request No. GAA-25-01-20635** for the **Supply and Delivery of Twenty (20) Units Laptops**, which was included in the **DOST-ASTI Annual Procurement Plan for Common-use Supplies and Equipment No. 4 for Fiscal Year 2025**.

WHEREAS, with an Approved Budget for the Contract (ABC) amounting to **Nine Hundred Ninety-Nine Thousand Nine Hundred Eighty Pesos Only (₱999,980.00)**, the mode of procurement is pursuant to Section 52 (b) (Shopping) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on **19 February 2025**, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to five (5) suppliers of known qualifications, viz: (1) *Jassen Harris Industries Corp.*; (2) *Quadstar Systems OPC*; (3) *Ace Electronic Technology Inc.*; (4) *3-Tech Innovation Master Corp.*; and (5) *C-Systems Technologies Inc.*;

WHEREAS, before the lapse of the deadline for submission of quotations on **24 February 2025, 2:00 PM**, three (3) bidders submitted quotations, particularly: (1) *Quadstar Systems OPC*; (2) *C-Systems Technologies Inc.*; and (3) *3-Tech Innovation Master Corp.*;

WHEREAS, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by **3-Tech Innovation Master Corp.** it was evidenced that the said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by **3-Tech Innovation Master Corp.** in the amount of **Nine Hundred Ninety-Five Thousand Three Hundred Pesos Only (₱995,300.00)**, inclusive of all government taxes and fees, are within the ABC and, thus, compliant with the financial requirements;

WHEREAS, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offer of **3-Tech Innovation Master Corp.** compliant with the technical requirements;

WHEREAS, **3-Tech Innovation Master Corp., Inc.** was determined to be the bidder with **Single Calculated Responsive Quotation**;

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

WHEREFORE, the **DOST-ASTI BAC RESOLVES**, as it is hereby **RESOLVED**, to recommend to the **DOST-ASTI HoPE**, for his approval, to award the contract for the **SUPPLY AND DELIVERY OF TWENTY (20) UNITS LAPTOPS** through **NEGOTIATED PROCUREMENT UNDER SECTION 53 (b) (SHOPPING)**, to **3-TECH INNOVATION MASTER CORP.** with a total bid amount of **NINE HUNDRED NINETY-FIVE THOUSAND THREE HUNDRED PESOS ONLY (P995,300.00)**, inclusive of all government taxes and fees.
