WHEREAS, the Finance and Administrative Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) Purchase Request No. GAA-25-02-20727 for the Supply and Delivery of Three Hundred (300) Pieces of 2025 National Women's Month Advocacy Polo Shirt and One Hundred (100) Pieces 2025 National Women's Month Advocacy Collaterals (Drawstring Bag) which were included in the DOST-ASTI Annual Procurement Plan No. 3 for Fiscal Year 2025. The procurement opportunity is broken down into the following items:

WHEREAS, with an Approved Budget for the Contract (ABC) amounting to One Hundred Seventeen Thousand Eight Hundred Fifty Pesos Only (\$\mathbb{P}\$117,850.00), the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on 04 March 2025, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to three (3) suppliers of known qualifications, viz: (1) Zioneyes General Merchandise; (2) VJ Graphic Arts, Inc.; and (3) Avecilla Trading;

WHEREAS, before the lapse of the deadline for submission of quotations on 07 March 2025, 2:00 PM, two (2) bidders submitted their respective quotations, particularly: (1) Avecilla Trading and (2) Zioneyes General Merchandise;

WHEREAS, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by Zioneyes General Merchandise it was evidenced that said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposals submitted by Zioneyes General Merchandise in the amount of One Hundred Seven Thousand Pesos Only (\$\mathbb{P}107,000.00), inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirement;

**WHEREAS,** Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

WHEREFORE, the DOST-ASTI BAC RESOLVES, as it is hereby RESOLVED, to recommend to the DOST-ASTI HoPE, for his approval, to award the contract for the SUPPLY AND DELIVERY OF THREE HUNDRED (300) PIECE OF 2025 NATIONAL WOMEN'S MONTH ADVOCACY POLO SHIRT AND ONE HUNDRED (100) PIECES 2025 NATIONAL WOMEN'S MONTH ADVOCACY COLLATERALS (DRAWSTRING BAG) through NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT), to ZIONEYES GENERAL MERCHANDISE with a total bid amount of ONE HUNDRED SEVEN THOUSAND PESOS ONLY (₱107,000.00), inclusive of all government taxes and fees (see below details).
