WHEREAS, the Solutions and Services Engineering Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) Purchase Request No. GAA-25-03-20793 for the Supply and Delivery of Vehicle Rental Services for REIINNFORCE Deployment - CAR and Region 2 which was included in the DOST-ASTI Annual Procurement Plan No. 1 for Fiscal Year 2025. The procurement opportunity is broken down into the following items:

WHEREAS, with an Approved Budget for the Contract (ABC) amounting to Sixty-Six Thousand Six Hundred Pesos Only (**P66,600.00**), the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on 14 March 2025, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to three (3) suppliers of known qualifications, viz: (1) Shayne Porte Bautista Travel & Tours; (2) Maynilad Tours; and (3) Froelich Tours;

WHEREAS, before the lapse of the deadline for submission of quotations on 17 March 2025, 2:00 PM, four (4) bidders submitted quotations, particularly (1) J.S. Placido Travel & Tours; (2) Shayne Porte Bautista Travel and Tours; (3) Thorita Transport Services; and (4) 7SQ OPC;

WHEREAS, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by 7SQ OPC it was evidenced that said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by 7SQ OPC in the amount of Fifty-Nine Thousand Nine Hundred Forty Pesos Only (₱59,940.00) inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirement:

WHEREAS, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offer of **7SQ OPC** compliant with the technical requirements;

WHEREAS, 7SQ OPC was determined to be the bidder with Lowest Calculated Responsive Quotation: and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

WHEREFORE, the DOST-ASTI BAC RESOLVES, as it is hereby RESOLVED, to recommend to the DOST-ASTI HOPE, for his approval, to award the contract for the SUPPLY AND DELIVERY OF VEHICLE RENTAL SERVICES FOR REIINNFORCE DEPLOYMENT - CAR AND REGION 2 through NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT), to 7SQ OPC with a total bid amount of FIFTY-NINE THOUSAND NINE HUNDRED FORTY PESOS ONLY (₱59,940.00), inclusive of all government taxes and fees (see below details).
