**RECOMMENDING THE AWARD OF CONTRACT TO VARIOUS SUPPLIERS FOR THE SUPPLY AND DELIVERY OF ONE (1) UNIT PROJECTOR SCREEN AND OTHER ITEMS**

**WHEREAS**, the Knowledge Management Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) **Purchase Request No. GAA-23-06-16930** for the **Supply and Delivery One (1) Unit Projector Screen and Other Items**, which was included in the **DOST-ASTI Annual Procurement Plan No. 10 for Fiscal Year 2023**. The procurement opportunity is broken down into the following items:

**WHEREAS**, with an Approved Budget for the Contract (ABC) amounting to **Ninety-Three Thousand Nine Hundred Ninety-Nine Pesos Only (₱93,999.00)**, the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

**WHEREAS**, on 20 June 2023, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to three (3) suppliers of known qualifications, viz: (1) Jassen Harris Industries Corp.; (2) Primetek International Non-Specialized Wholesale Trading; and (3) Lyric Piano & Organ Corporation;

**WHEREAS**, before the lapse of the deadline for submission of quotations on 23 June 2023, 2:00 PM, three (3) bidders submitted quotations, viz: **(1) Artjohnley Enterprises; (2) JDR Trading Services; and (3) Lyric Piano & Organ Corp.**;

**WHEREAS**, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by **JDR Trading Services** and **Lyric Piano & Organ Corp.**, it was evidenced that said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by **JDR Trading Services** and **Lyric Piano & Organ Corp.** in the amount of **Thirty-Nine Thousand Two Hundred Seventy Pesos Only (₱39,270.00)** and **Forty-Five Thousand Pesos Only (₱45,000.00)**, inclusive of all government taxes and fees, are within the ABC and, thus, compliant with the financial requirement;

**WHEREAS**, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offers of **JDR Trading Services** and **Lyric Piano & Organ Corp.** compliant with the technical requirements;


**WHEREAS**, **JDR Trading Services** and **Lyric Piano & Organ Corp.** were determined to be the bidders with **Lowest Calculated Responsive Quotations**; and

**WHEREAS**, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

**WHEREFORE**, the **DOST-ASTI BAC RESOLVES**, as it is hereby **RESOLVED**, to recommend to the **DOST-ASTI HoPE**, for his approval, the following:

- (1) To award the contract for the **SUPPLY AND DELIVERY OF ONE (1) UNIT OF PROJECTOR SCREEN** through **NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT)**, to **JDR TRADING SERVICES**, with a total bid amount of **THIRTY-NINE THOUSAND TWO HUNDRED SEVENTY PESOS ONLY (₱39,270.00)**, inclusive of all government taxes and fees; and
- (2) To award the contract for the **SUPPLY AND DELIVERY OF ONE (1) UNIT OF AUDIO MIXER WITH USB INTERFACE** through **NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT)**, to **LYRIC PIANO & ORGAN CORP.**, with a total bid amount of **FORTY-FIVE THOUSAND PESOS ONLY (₱45,000.00)**, inclusive of all government taxes and fees;
