**RECOMMENDING THE AWARD OF CONTRACT TO 3RLFD TRANSPORTATION SERVICES FOR THE  
SUPPLY AND DELIVERY OF TEN (10) LOTS VEHICLE RENTAL**

**WHEREAS**, the Computer Software Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) **Purchase Request No. ALAM-25-05-21217** for the **Supply and Delivery of Ten (10) Lots Vehicle Rental** which was included in the **DOST-ASTI Annual Procurement Plan No. 6 for Fiscal Year 2025**;

**WHEREAS**, with an Approved Budget for the Contract (ABC) amounting to **One Hundred Thousand Pesos Only (₱100,000.00)**, the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

**WHEREAS**, on **21 May 2025**, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to three (3) suppliers of known qualifications, viz: (1) Field & Outdoor Explore Travels Services; (2) 3RLFD Transportation Services; and (3) Nicojhuen Transport Services;

**WHEREAS**, before the lapse of the deadline for submission of quotations on **26 May 2025, 2:00 PM**, two (2) bidders submitted their respective quotations, particularly: **(1) 3RLFD Transportation Services** and **(2) On-Track Express Transport Services**;

**WHEREAS**, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by **3RLFD Transportation Services** it was evidenced that said prospective bidders complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposals submitted by **3RLFD Transportation Services** in the amount of **Ninety-Five Thousand Pesos Only (₱95,000.00)**, inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirement;

**WHEREAS**, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offer of **3RLFD Transportation Services** compliant with the technical requirements;

**WHEREAS**, **3RLFD Transportation Services** was determined to be the bidder with **Lowest Calculated Responsive Quotation**; and

**WHEREAS**, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

**WHEREFORE**, the **DOST-ASTI BAC RESOLVES**, as it is hereby **RESOLVED**, to recommend to the **DOST-ASTI HoPE**, for his approval, to award the contract for the **SUPPLY AND DELIVERY OF TEN (10) LOTS VEHICLE RENTAL** through **NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT)**, to **3RLFD TRANSPORTATION SERVICES** with a total bid amount of **NINETY-FIVE THOUSAND PESOS ONLY (₱95,000.00)**, inclusive of all government taxes and fees.
