**RECOMMENDING THE AWARD OF CONTRACT TO JDR TRADING SERVICES FOR THE  
SUPPLY AND DELIVERY OF THREE (3) UNITS TRIPLE PORTABLE LAPTOP SCREEN

**WHEREAS**, the Computer Software Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) **Purchase Request No. GAA-25-05-21195** for the **Supply and Delivery of Three (3) Units Triple Portable Laptop Screen Extender** which was included in the **DOST-ASTI Annual Procurement Plan No. 4 for Fiscal Year 2025**;

**WHEREAS**, with an Approved Budget for the Contract (ABC) amounting to **One Hundred Fourteen Thousand Pesos Only (₱114,000.00)**, the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

**WHEREAS**, on **20 May 2025**, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to three (3) suppliers of known qualifications, viz: (1) Jassen Harris Industries Corp.; (2) 3-Tech Innovation Master Corp.; and (3) C-Systems Technologies Incorporated;

**WHEREAS**, before the lapse of the deadline for submission of quotations on **23 May 2025, 2:00 PM**, three (3) bidders submitted their respective quotations, particularly: **(1) BayanPC Technologies, Inc.**; **(2) JDR Trading Services**; and **(3) 3-Tech Innovation Master Corp.**;

**WHEREAS**, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by **JDR Trading Services** it was evidenced that said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by **JDR Trading Services** in the amount of **Ninety-Four Thousand Seven Hundred Forty-Five Pesos and 70/100 Only (₱94,745.70)**, inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirement;

**WHEREAS**, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offer of **JDR Trading Services** was compliant with the technical requirements;

**WHEREAS**, **JDR Trading Services** was determined to be the bidder with **Single Calculated Responsive Quotation**; and

**WHEREAS**, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

**WHEREFORE, the DOST-ASTI BAC RESOLVES, as it is hereby RESOLVED, to recommend to the DOST-ASTI HoPE, for his approval, to award the contract for the SUPPLY AND DELIVERY OF THREE (3) UNITS TRIPLE PORTABLE LAPTOP SCREEN EXTENDER through NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT), to JDR TRADING SERVICES with a total bid amount of NINETY-FOUR THOUSAND SEVEN HUNDRED FORTY-FIVE PESOS AND 70/100 ONLY (P94,745.70), inclusive of all government taxes and fees.**
