## RECOMMENDING THE AWARD OF CONTRACT TO DREAM FAVOR TRAVEL & TOURS FOR THE PROVISION OF ONE (1) LOT VEHICLE RENTAL SERVICES - MARINDUQUE

WHEREAS, the Research and Development Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) Purchase Request No. FASTRACRoa-25-06-21423 for the Provision of One (1) Lot Vehicle Rental Services - Marinduque and South Cotabato, which was included in the DOST-ASTI Annual Procurement Plan No. 8 for Fiscal Year 2025. The procurement opportunity is broken down into the following items:

WHEREAS, with an Approved Budget for the Contract (ABC) amounting to **Eighty-Four Thousand Four Hundred Twenty-Five Pesos Only (₱84,425.00)**, the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

**WHEREAS,** on **19 June 2025**, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to four (4) suppliers of known qualifications, *viz*: (1) Dream Favor Travel and Tours; (2) Luzon Datum Transport Service Cooperative; (3) Marinduque-Quezon Transport Shuttle Service Cooperative (Marquez); and (4) Estimo Van Transport;

WHEREAS, before the lapse of the deadline for submission of quotations on 23 June 2025, 2:00 PM, only one (1) bidder submitted its quotation, particularly: (1) Dream Favor Travel and Tours;

WHEREAS, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by **Dream Favor Travel and Tours** it was evidenced that said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by **Dream Favor Travel and Tours** in the amount of **Sixty-One Thousand Pesos Only (₱61,000.00)** inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirement;

WHEREAS, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offer of **Dream Favor Travel and Tours** compliant with the technical requirements;

WHEREAS, Dream Favor Travel and Tours was determined to be the bidder with Single Calculated Responsive Quotation; and

**WHEREAS,** Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

WHEREFORE, the DOST-ASTI BAC RESOLVES, as it is hereby RESOLVED, to recommend to the DOST-ASTI HoPE, for his approval, the following:
