WHEREAS, on 10 June 2025, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to five (5) suppliers of known qualifications, viz: (1) Jassen Harris Industries Corp.; (2) Ace Electronic Technology, Inc.; (3) 3-Tech Innovation Master Corp.; (4) Bayan PC Technologies; and (5) CMB Betsmart Tchnlgy;

ASTI – FM 03-13 REV 4 / 10 June 2025 WHEREAS, before the lapse of the deadline for submission of quotations on 13 June 2025, 2:00 PM, three (3) bidders submitted quotations, particularly: (1) Jassen Harris Industries Corp.; (2) CL Sia Trading; and (3) Ace Electronic Technology, Inc.;

WHEREAS, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by Ace Electronic Technology, Inc. and Jassen Harris Industries Corp. it was evidenced that the said prospective bidders complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposals submitted by Ace Electronic Technology, Inc. in the amount of Six Thousand Pesos Only (₱6,000.00) and Jassen Harris Industries Corp. in the amount of One Hundred Thirty-Seven Thousand Forty-Four Pesos Only (₱137,044.00), inclusive of all government taxes and fees, are within the ABC and, thus, compliant with the financial requirements;

WHEREAS, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offers of Ace Electronic Technology, Inc. and Jassen Harris Industries Corp. compliant with the technical requirements;

WHEREAS, Ace Electronic Technology, Inc. and Jassen Harris Industries Corp. were determined to be the bidders with Lowest Calculated Responsive Quotations; and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

WHEREFORE, the DOST-ASTI BAC RESOLVES, as it is hereby RESOLVED, to recommend to the DOST-ASTI HoPE, for his approval, the following:

1) To award the contract for the SUPPLY AND DELIVERY OF FIVE (5) PIECES EXTENSION WIRE 5M through NEGOTIATED PROCUREMENT UNDER SECTION 53 (b) (SHOPPING), to ACE ELECTRONIC TECHNOLOGY, INC. with a total bid amount of SIX THOUSAND PESOS ONLY (₱6,000.00), inclusive of all government taxes and fees;
