WHEREAS, the Solutions and Services Engineering Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) Purchase Request No. GAA-25-06-21480 for the Supply and Delivery of One (1) Lot Customized DOST-ASTI Tokens and One (1) Lot DOST-ASTI Customized Polo Shirts which was included in the DOST-ASTI Annual Procurement Plan No. 9 for Fiscal Year 2025. WHEREAS, with an Approved Budget for the Contract (ABC) amounting to Three Hundred Sixty-Seven Thousand Five Hundred Pesos Only (₱367,500.00), the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on 26 June 2025, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to three (3) suppliers of known qualifications, viz: (1) Zioneyes General Merchandise; (2) Tanjer Enterprise; and (3) Dart Printing;

WHEREAS, before the lapse of the deadline for submission of quotations on 30 June 2025, 2:00 PM, two (2) bidders submitted their respective quotations, particularly: (1) Zioneyes General Merchandise and (2) Nicatto Events and Marketing Dynamics Corp.;

WHEREAS, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by Zioneves General Merchandise it was evidenced that said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by Zioneyes General Merchandise in the amount of Three Hundred Sixteen Thousand Nine Hundred Sixty Pesos Only (₱316,960.00) inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirement;

WHEREFORE, the DOST-ASTI BAC RESOLVES, as it is hereby RESOLVED, to recommend to the DOST-ASTI HoPE, for his approval, to award the contract for the SUPPLY AND DELIVERY OF ONE (1) LOT CUSTOMIZED DOST-ASTI TOKENS AND ONE (1) LOT DOST-ASTI CUSTOMIZED POLO SHIRTS through NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT), to ZIONEYES GENERAL MERCHANDISE with a total bid amount of THREE HUNDRED SIXTEEN THOUSAND NINE HUNDRED SIXTY PESOS ONLY (₱316,960.00), inclusive of all government taxes and fees (see below details).
