WHEREAS, the Solutions and Services Engineering Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) Purchase Request No. GAA-25-06-21479 for the Supply and Delivery of One (1) Lot ASTICON Customized Conference Bag and One (1) Lot ASTICON Customized Lanyards which was included in the DOST-ASTI Annual Procurement Plan No. 9 for Fiscal Year 2025. WHEREAS, with an Approved Budget for the Contract (ABC) amounting to Seventy-Eight Thousand One Hundred Forty Pesos Only (₱78,140.00), the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on 26 June 2025, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to three (3) suppliers of known qualifications, *viz*: (1) Zioneyes General Merchandise; (2) VJ Graphic Arts, Inc.; and (3) Tanjer Enterprise;

WHEREAS, before the lapse of the deadline for submission of quotations on 30 June 2025, 2:00 PM, one (1) bidder submitted its quotation, particularly: (1) Zioneyes General Merchandise;

WHEREAS, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by Zioneyes General Merchandise it was evidenced that said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by Zioneyes General Merchandise in the amount of Seventy-Three Thousand Seven Hundred Pesos Only (₱73,700.00), inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirement;

WHEREAS, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offer of **Zioneyes General Merchandise** compliant with the technical requirements;

WHEREFORE, the DOST-ASTI BAC RESOLVES, as it is hereby RESOLVED, to recommend to the DOST-ASTI HoPE, for his approval, to award the contract for the SUPPLY AND DELIVERY OF ONE (1) LOT ASTICON CUSTOMIZED CONFERENCE BAG AND ONE (1) LOT ASTICON CUSTOMIZED LANYARDS through NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT), to ZIONEYES GENERAL MERCHANDISE with a total bid amount of SEVENTY-THREE THOUSAND SEVEN HUNDRED PESOS ONLY (₱73,700.00), inclusive of all government taxes and fees (see below details).
