WHEREAS, the Office of the Director submitted to the DOST-ASTI Bids and Awards Committee (BAC) Purchase Request No. GAA-25-07-21572 for the Provision of ASTICON 2025 and DOST-ASTI Service Award Live Event Production Services which was included in the DOST-ASTI Annual Procurement Plan No. 12 for Fiscal Year 2025.

WHEREAS, with an Approved Budget for the Contract (ABC) amounting to Six Hundred Sixty Thousand Pesos Only (₱660,000.00), the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on 13 July 2025, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to three (3) suppliers of known qualifications, viz: (1) Red Root Artists & Artisans Multi-purpose Cooperative; (2) Avolution, Inc.; and (3) Stage Craft International, Inc.;

WHEREAS, before the lapse of the deadline for submission of quotations on 16 July 2025, 2:00 PM, three (3) bidders submitted their respective quotations, particularly: (1) Red Root Artists & Artisans Multi-purpose Cooperative; (2) Business Unusual Media Sol. Inc.; and (3) Mabuhay Studio Inc.:

WHEREAS, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by Red Root Artists & Artisans Multi-purpose Cooperative, it was evidenced that said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by Red Root Artists & Artisans Multi-purpose Cooperative in the amount of Six Hundred Forty Thousand Pesos Only (₱640,000.00) inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirement;

WHEREAS, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offer of Red Root Artists & Artisans Multipurpose Cooperative compliant with the technical requirements;

WHEREAS, Red Root Artists & Artisans Multi-purpose Cooperative was determined to be the bidder with Single Calculated Responsive Quotation; and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.
