**RECOMMENDING THE AWARD OF CONTRACT TO GAMEVILLE CORPORATION FOR THE  
SUPPLY AND DELIVERY OF ONE (1) LOT SPORTS UNIFORM**

**WHEREAS**, the Finance and Administrative Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) **Purchase Request No. GAA-23-04-16625** for the **Supply and Delivery of One (1) Lot Sports Uniform**, which was included in the **DOST-ASTI Supplemental Annual Procurement Plan No. 9 for Fiscal Year 2023**;

**WHEREAS**, with an Approved Budget for the Contract (ABC) amounting to **Sixty-Seven Thousand Five Hundred Pesos Only (₱67,500.00)**, the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

**WHEREAS**, on **04 May 2023**, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to three (3) suppliers of known qualifications, viz: (1) Kaifashion Philippines Inc.; (2) GM Garments Contractor; and (3) EZ Jersey OPC;

**WHEREAS**, before the lapse of the deadline for submission of quotations on **08 May 2023, 2:00 PM**, three (3) bidders submitted quotations, particularly **(1) Kaifashion Philippines, Inc.**; **(2) EZ Jersey OPC**; and **(3) Gameville Corporation**;

**WHEREAS**, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by **Gameville Corp.**, it was evidenced that said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by **Gameville Corp.**, in the amount of **Fifty-Three Thousand Two Hundred Pesos Only (₱53,200.00)**, inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirements;

**WHEREAS**, the evaluation of the compliance with the technical specifications of the procurement project was done by the end-user unit, which found the offer of **Gameville Corp.** compliant with the technical requirements;


**WHEREAS**, **Gameville Corp.**, was determined to be the bidder with the **Lowest Calculated Responsive Quotation**; and

**WHEREAS**, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

**WHEREFORE**, the **DOST-ASTI BAC RESOLVES**, as it is hereby **RESOLVED**, to recommend to the **DOST-ASTI HoPE**, for his approval, to award the contract for the **SUPPLY AND DELIVERY OF ONE (1) LOT OF SPORTS UNIFORM**, through **NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT)**, to **GAMEVILLE CORP.** with a total bid amount of **FIFTY-**

**THREE THOUSAND TWO HUNDRED PESOS ONLY (P53,200.00)**, inclusive of all government taxes and fees.
