**RECOMMENDING THE EXTENSION OF CONTRACT WITH PLDT, INC. FOR THE SUPPLY, DELIVERY AND INSTALLATION OF LOCAL TRANSPORT – MANILA TO CEBU (SECONDARY), 1GBPS**

**WHEREAS**, the Bids and Awards Committee (BAC) of the Department of Science and Technology (DOST) - Advanced Science and Technology Institute (ASTI) received Purchase Request No. **INNOVATE-25-09-22038** dated **23 September 2025**, for the “**Contract Extension of Local Transport – Manila to Cebu Secondary 1Gbps**”, which is in the DOST-ASTI Indicative Annual Procurement Plan (APP) for Fiscal Year (FY) 2026 with an Approved Budget for the Contract (ABC) amounting to **Six Hundred Seventy-Eight Thousand Five Hundred Twenty-Five Pesos Only (₱678,525.00)**, inclusive of all government taxes, other charges, viz:

**WHEREAS**, pursuant to Section 18. Renewal of Regular Recurring Services of the Implementing Rules and Regulations of Republic Act (RA) No. 12009, refer to those:

1. *“Those which by their nature are necessary to the day-to-day operations of the Procuring Entity such as (i) janitorial services; (ii) security services; (iii) telecommunication requirements; (iv) supply of drinking water; (v) rental of office space, or lease of venue, and equipment; (vi) fuel fleet card services; (vii) water supply and distribution services (viii) electricity distribution; and (ix) other services as may be determined by the DBM;*
2. *Services that, by their nature, are deemed essential, indispensable, or necessary to the day-to-day operations of the Procuring Entity; and*
3. *Services that have been procured repeatedly by the Procuring Entity over the past three (3) years.”*

**WHEREAS**, the end-user conducted a Cost-Benefit Analysis (CBA) to determine the available providers for said procurement project. Only one (1) bidder submitted a quotation, specifically **PLDT, Inc.**;

**WHEREAS**, based on the submitted quotation/s, the following data were gathered by the end-user:

**WHEREAS**, based on the submitted performance evaluation of the service provider on the Contract Extension of Local Transport - Manila to Cebu Secondary 1Gbps, **PLDT, Inc.** provided satisfactory performance to the Procuring Entity (PE);

**WHEREAS**, the DOST-ASTI BAC validated the CBA, performance evaluation, and the updated eligibility documents of the service provider;

**WHEREAS**, the DOST-ASTI BAC perceived that the extension of **PLDT, Inc.’s** contract remains most advantageous to the PE;

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the DOST-ASTI BAC, hereby RESOLVE, as it is hereby RESOLVED to recommend to the Head of the Procuring Entity, the following:

- 1) Inclusion of the extension of contract in the final and approved Fiscal Year 2026 APP of the DOST-ASTI;
- 2) Approve the extension of contract with **PLDT, Inc.**, for the “**Contract Extension of Local Transport – Manila to Cebu Secondary 1Gbps**” from 01 January 2026 to 31 March 2026, in the amount of **Six Hundred Seventy-Eight Thousand Five Hundred Twenty-Five Pesos Only (P678,525.00)**, inclusive of all government taxes and fees, and issue Notice of Extension for said purpose; and
