**WHEREAS**, the Office of the Director submitted to the Bids and Awards Committee (BAC) Purchase Request No. GAA-22-03-13351 for the Supply and Delivery of Software Licenses-Subscription-Graphic Design Software Suite and Other Item (**Annex "A"**) with an Approved Budget for the Contract amounting to Five Hundred Forty-Three Thousand Five Hundred Sixty-Seven Pesos Only (P543,567.00) which was included in the Supplemental Annual Procurement Plan (APP) No. 5 for Fiscal Year 2022 (**Annex "B"**). The procurement opportunity is broken down into the following items:

**WHEREAS**, the mode of procurement is based on Item No. 8, Annex "H" of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, which provides that the Procuring Entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed One Million Pesos (P1,000,000.00);

**WHEREAS**, on 24 March 2022, the BAC published the Request for Quotation (**Annex "C"**) and invited three (3) suppliers of known qualifications to participate in said procurement, namely: (1) Tiger Consulting and Software Devt, Inc. (2) K.O.B.S Customers First Trading, Inc., and (3) MyBusybee, Inc.;

**WHEREAS**, the End-user forwarded to the BAC Secretariat its evaluation (**Annex "D"**) which found the offers of Tiger Consulting and Software Devt, Inc. and Datacore Technologies, Inc. compliant with the eligibility requirements and specifications, which were verified by the BAC. Their quotations, with total amounts of Three Hundred Twenty-Six Thousand One Hundred Ninety-Seven Pesos & 50/100 Only (P326,197.50) and One Hundred Forty-Six Thousand Pesos Only (P146,000.00), inclusive of all government taxes and fees, are deemed the most advantageous to the government, as the single and lowest calculated responsive quotations, respectively;

**WHEREAS**, the BAC finds the recommendation of the End-user in compliance with RA No. 9184 and its 2016 revised IRR; and

**WHEREAS**, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

**NOW, THEREFORE**, for and in consideration of the foregoing, **WE**, the Members of the BAC, hereby **RECOMMEND** to the HoPE the following:
