RECOMMENDING THE AWARD OF CONTRACT TO VARIOUS SUPPLIERS
FOR THE SUPPLY AND DELIVERY OF THREE (3) UNITS MONITOR AND OTHER ITEMS

WHEREAS, the Finance and Administrative Division submitted to the Bids and Awards Committee (BAC) Purchase Request No. GAA-22-04-13637 for the Supply and Delivery of One (1) Unit Pressure Washer and Other Items (**Annex "A"**) with an Approved Budget for the Contract amounting to Fifty-Six Thousand Two Hundred Pesos Only (₱56,200.00) which was included in the Supplemental Annual Procurement Plan (APP) No. 3 & 8 for Fiscal Year 2022 (**Annex "B"**). The procurement opportunity is broken down into the following items:

WHEREAS, the mode of procurement is based on Item No. 8, Annex "H" of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, which provides that the Procuring Entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed One Million Pesos (₱1,000,000.00);

WHEREAS, on 07 May 2022, the BAC published the Request for Quotation (**Annex "C"**) and invited three (3) suppliers of known qualifications to participate in said procurement, namely: (1) Jassen Harris Industries Corp., (2) Gemstone Enterprise, and (3) ArtJohnley Enterprises;

WHEREAS, the End-user forwarded to the BAC Secretariat its evaluation (**Annex "D"**) which found the offers of Jassen Harris Industries Corp. and Gemstone Enterprise compliant with the eligibility requirements and specifications, which were verified by the BAC. Their quotations, with total amounts of Twenty-Nine Thousand Six Hundred Ninety-Seven Pesos Only (₱29,697.00) and Seventeen Thousand Seven Hundred Forty Pesos Only (₱17,740.00), inclusive of all government taxes and fees, is deemed the most advantageous to the government, as the single calculated responsive quotation, respectively;

WHEREAS, the BAC finds the recommendation of the End-user in compliance with RA No. 9184 and its 2016 revised IRR; and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the Members of the BAC, hereby **RECOMMEND** to the HoPE the following:

- 1) AWARD OF CONTRACT** via Small Value Procurement to **JASSEN HARRIS INDUSTRIES CORP.** for the **SUPPLY AND DELIVERY OF THREE (3) UNITS MONITOR** in the amount of **TWENTY-NINE THOUSAND SIX HUNDRED NINETY-SEVEN PESOS ONLY (₱29,697.00)** inclusive of all appropriate taxes and fees;

- 2) **AWARD OF CONTRACT** via Small Value Procurement to **GEMSTONE ENTERPRISE** for the **SUPPLY AND DELIVERY OF TWO (2) UNITS TABLE** in the amount of **SEVENTEEN THOUSAND SEVEN HUNDRED FORTY PESOS ONLY (P17,740.00)** inclusive of all appropriate taxes and fees;
- 3) **DECLARE** procurement failure for the Supply and Delivery of One (1) Unit Pressure Washer, as the bidder's line of business is not authorized to engage with the item; and
- 4) **APPROVAL** of the foregoing result/s.
