RECOMMENDING THE AWARD OF CONTRACT TO EDUKSINE PRODUCTION CORPORATION FOR THE SUPPLY AND DELIVERY OF ONE (1) LOT MOVIE RENTAL FOR NATIONAL WOMEN'S MONTH CELEBRATION 2023

WHEREAS, the Finance and Administrative Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) **Purchase Request Nos. GAA-23-02-16234 for the Supply and Delivery of One (1) Lot Movie Rental for National Women's Month Celebration 2023**, which was included in the **DOST-ASTI Supplemental Annual Procurement Plan No. 4 for Fiscal Year 2023**;

WHEREAS, with an Approved Budget for the Contract (ABC) amounting to **Sixty-Three Thousand Seven Hundred Thirty-Three Pesos & 34/100 Only (₱63,733.34)**, the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on 02 March 2023, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to three (3) suppliers of known qualifications, viz: (1) Eduksine Production Corporation; (2) Film Philippines; and (3) Model Shop Studios;

WHEREAS, before the lapse of the deadline for submission of quotations on 06 March 2023, 2:00 PM, only one (1) bidder submitted a quotation, particularly **Eduksine Production Corporation**;

WHEREAS, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by **Eduksine Production Corporation**, it was evidenced that said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by **Eduksine Production Corporation**, in the amount of **Sixty-Three Thousand Seven Hundred Thirty-Three Pesos & 34/100 Pesos Only (₱63,733.34)**, inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirement;

WHEREAS, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offer of **Eduksine Production Corporation** compliant with the technical requirements;


WHEREAS, **Eduksine Production Corporation** was determined to be the bidder with **Single Calculated Responsive Quotation**; and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

WHEREFORE, the **DOST-ASTI BAC RESOLVES**, as it is hereby **RESOLVED**, to recommend to the **DOST-ASTI HoPE**, for his approval, to award the contract for the **SUPPLY AND DELIVERY OF ONE (1) LOT MOVIE RENTAL FOR NATIONAL WOMEN'S MONTH CELEBRATION 2023**, through **NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT)**, to

EDUKSINE PRODUCTION CORPORATION, with a total bid amount of **SIXTY-THREE THOUSAND SEVEN HUNDRED THIRTY-THREE PESOS & 34/100 PESOS ONLY (₱63,733.34)**, inclusive of all government taxes and fees.
