**RECOMMENDING THE AWARD OF CONTRACT TO 3RLFD TRANSPORTATION SERVICES FOR THE SUPPLY AND DELIVERY OF ONE (1) LOT VEHICLE RENTAL FOR SERVER CONFIGURATION IN NTC REGIONAL OFFICE NO. VIII AND OTHER ITEMS**

**WHEREAS**, the Solutions and Services Engineering Division submitted to the DOST-ASTI Bids and Awards Committee (BAC) **Purchase Request No. NetMeshR3-23-04-16566** for the **Supply and Delivery of One (1) Lot Vehicle Rental for Server Configuration in NTC Regional Office No. VIII and Other Items**, which was included in the **DOST-ASTI Supplemental Annual Procurement Plan No. 8 for Fiscal Year 2023**. The procurement opportunity is broken down into the following items:

**WHEREAS**, with an Approved Budget for the Contract (ABC) amounting to **Seventy-Three Thousand Pesos Only (₱73,000.00)**, the mode of procurement is pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

**WHEREAS**, on **25 April 2023**, the DOST-ASTI BAC, through its Secretariat, published the Request for Quotation (RFQ) and sent RFQs to three (3) suppliers of known qualifications, viz: (1) 3RLFD Transportation Services; (2) Shayne Porte Bautista Travel & Tours; and (3); Thorita Transportation Services;

**WHEREAS**, before the lapse of the deadline for submission of quotations on **28 April 2023, 2:00 PM**, only one (1) bidder submitted a quotation, particularly **3RLFD Transportation Services**;

**WHEREAS**, upon careful review and evaluation of the DOST-ASTI BAC on the legal requirements submitted by **3RLFD Transportation Services**, it was evidenced that said prospective bidder complied with the eligibility requirements. Likewise, the DOST-ASTI BAC determined that the financial proposal submitted by **3RLFD Transportation Services**, in the amount of **Seventy-Three Thousand Pesos Only (₱73,000.00)**, inclusive of all government taxes and fees, is within the ABC and, thus, compliant with the financial requirements;

**WHEREAS**, the evaluation of the compliance with the technical requirements of the procurement project was done by the end-user unit, which found the offer of **3RLFD Transportation Services** compliant with the technical requirements;


**WHEREAS, 3RLFD Transportation Services**, was determined to be the bidder with the **Single Calculated Responsive Quotation**; and

**WHEREAS**, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

**WHEREFORE**, the **DOST-ASTI BAC RESOLVES**, as it is hereby **RESOLVED**, to recommend to the **DOST-ASTI HoPE**, for his approval, to award the contract for the **SUPPLY AND DELIVERY OF ONE (1) LOT VEHICLE RENTAL FOR SERVER CONFIGURATION IN NTC REGIONAL OFFICE NO. VIII AND OTHER ITEMS**, through **NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT)**, to **3RLFD TRANSPORTATION SERVICES** with a total bid amount of **SEVENTY-THREE THOUSAND PESOS ONLY (₱73,000.00)**, inclusive of all government taxes and fees (*see below details*).
