RECOMMENDING THE AWARD OF CONTRACT TO JASSEN HARRIS INDUSTRIES CORP. FOR THE SUPPLY AND DELIVERY OF ONE (1) UNIT MOBILE DEVICES FOR MOBILE APPLICATION TESTING FOR OS VERSION: ANDROID 11.0 PIE OR HIGHER AND OTHER ITEMS

WHEREAS, the Computer Software Division submitted to the Bids and Awards Committee (BAC) Purchase Request No. GAA-22-06-14026 for the Supply and Delivery of One (1) unit Mobile devices for mobile application testing for OS version: Android 11.0 Pie or higher and Other Items (**Annex “A”**) with an Approved Budget for the Contract amounting to One Hundred Twelve Thousand Eight Hundred Fifty-One Pesos Only (₱112,851.00) which was included in the Supplemental Annual Procurement Plan (APP) No. 09 for Fiscal Year 2022 (**Annex “B”**). The procurement opportunity is broken down into the following items:

WHEREAS, the mode of procurement is based on Item No. 8, Annex “H” of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, which provides that the Procuring Entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed One Million Pesos (₱1,000,000.00);

WHEREAS, on 29 June 2022, the BAC published the Request for Quotation (**Annex “C”**) and invited three (3) suppliers of known qualifications to participate in said procurement, namely: 1) Jassen Harris Industries Corp.; 2) Ace Electronic Technology, Inc.; and 3) Artjohnley Enterprises.;

WHEREAS, before the lapse of the deadline for submission of quotation at 2:00 in the afternoon on 04 July 2022, two (2) suppliers submitted quotations, viz: 1) Jassen Harris Industries Corp. and 2) Artjohnley Enterprises;

WHEREAS, the End-user forwarded to the BAC Secretariat its evaluation (**Annex “D”**) which found the offer of Jassen Harris Industries Corp. compliant with the eligibility requirements and specifications, which was verified by the BAC. Its quotation, with a total amount of One Hundred Ten Thousand Four Hundred Sixty Pesos Only (₱110,460.00) inclusive of all government taxes and fees, is deemed the most advantageous to the government, as the other quotation failed to meet the specifications;

WHEREAS, the BAC finds the recommendation of the End-user in compliance with RA No. 9184 and its 2016 revised IRR; and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the Members of the BAC, hereby **RECOMMEND** to the HoPE the following:

- 1) **AWARD OF CONTRACT** via Small Value Procurement to **JASSEN HARRIS INDUSTRIES CORP** for the **SUPPLY AND DELIVERY OF ONE (1) UNIT MOBILE DEVICES FOR MOBILE APPLICATION TESTING FOR OS VERSION: ANDROID 11.0 PIE OR HIGHER AND OTHER ITEMS** in the amount of **ONE HUNDRED TEN THOUSAND FOUR HUNDRED SIXTY PESOS ONLY (₱110,460.00)** inclusive of all appropriate taxes and fees; and
