**RECOMMENDING THE AWARD OF CONTRACT TO VARIOUS SUPPLIERS FOR THE
SUPPLY AND DELIVERY OF TWO (2) UNITS DIGITAL PEN TABLET WITH BLUETOOTH
AND OTHER ITEMS**

WHEREAS, the Computer Software Division submitted to the Bids and Awards Committee (BAC) Purchase Request No. GAA-22-03-13324 for the Supply and Delivery of Two (2) units Digital Tablet with Bluetooth and Other Items (**Annex "A"**) with an Approved Budget for the Contract amounting to One Hundred Ten Thousand Four Hundred Fifty-Three Pesos & 38/100 Only (₱110,453.38) which was included in the Final and Approved Annual Procurement Plan (APP) for Fiscal Year 2022 (**Annex "B"**). The procurement opportunity is broken down into the following items:

WHEREAS, the mode of procurement is based on Item No. 8, Annex "H" of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, which provides that the Procuring Entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed One Million Pesos (₱1,000,000.00);

WHEREAS, on 26 March 2022, the BAC published the Request for Quotation (**Annex "C"**) and invited three (3) suppliers of known qualifications to participate in said procurement, namely: (1) Jassen Harris Industries Corp. (2) Ace Electronic Technology, Inc., and (3) C-Systems Technologies, Inc.;

WHEREAS, the End-user forwarded to the BAC Secretariat its evaluation (**Annex "D"**) which found the offers of Jassen Harris Industries Corp. and JDR Trading Services compliant with the eligibility requirements and specifications, which was verified by the BAC. Their quotations, with total amounts of Fifteen Thousand Pesos Only (₱15,000.00) and Eighty-Two Thousand Two Hundred Fifty Pesos Only (₱82,250.00), inclusive of all government taxes and fees, are deemed the most advantageous to the government, as the lowest calculated responsive quotations, respectively;

WHEREAS, the BAC finds the recommendation of the End-user in compliance with RA No. 9184 and its 2016 revised IRR; and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the Members of the BAC, hereby **RECOMMEND** to the HoPE the following:

- 1) AWARD OF CONTRACT** via Small Value Procurement to **JASSEN HARRIS INDUSTRIES CORP.** for the **SUPPLY AND DELIVERY OF TWO (2) UNITS DIGITAL PEN TABLET WITH BLUETOOTH** in the amount of **FIFTEEN THOUSAND PESOS ONLY (₱15,000.00)**, inclusive of all appropriate taxes and fees;


