WHEREAS, the Office of the Director submitted to the Bids and Awards Committee (BAC) Purchase Request No. GAA-22-08-14464 for the Supply and Delivery of Software License - Perpetual - Multi-box Layout Pack for Live Production Switcher and Other Items (Annex "A") with an Approved Budget for the Contract (ABC) amounting to One Hundred Thirty-Nine Thousand Pesos Only (₱139,000.00) which was included in the Supplemental Annual Procurement Plan (APP) No. 14 for Fiscal Year 2022 (Annex "B"). The procurement opportunity is broken down into the following items:

WHEREAS, the mode of procurement is based on Item No. 8, Annex "H" of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, which provides that the Procuring Entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed One Million Pesos (₱1,000,000.00);

WHEREAS, on 08 September 2022, the BAC published the Request for Quotation (Annex "C") and invited three (3) suppliers of known qualifications to participate in said procurement, namely: (1) Datacore Technologies, Inc., (2) Tiger Consulting and Software Dev't, Inc., and (3) MyBusybee, Inc.;

WHEREAS, before the lapse of the deadline for submission of quotation at 2:00 in the afternoon on 12 September 2022, only one (1) supplier submitted their quotation, particularly, Datacore Technologies, Inc.;

WHEREAS, the End-user forwarded to the BAC Secretariat its evaluation (Annex "D") which found the offer of Datacore Technologies, Inc compliant with the eligibility requirements and specifications, which was verified by the BAC. Its quotation, with a total amount of One Hundred Thirty-Eight Thousand Seven Hundred Fifty Pesos Only (₱138,750.00), inclusive of all government taxes and fees, is deemed the most advantageous to the government, as the single calculated responsive quotation;

WHEREAS, the BAC finds the recommendation of the End-user in compliance with RA No. 9184 and its 2016 revised IRR; and
