**RECOMMENDING THE AWARD OF CONTRACT TO VARIOUS SUPPLIERS
FOR THE SUPPLY AND DELIVERY OF THREE (3) UNITS TABLETS AND OTHER ITEMS**

WHEREAS, the Finance and Administrative Division submitted to the Bids and Awards Committee (BAC) Purchase Request No. GAA-21-05-11387 for the Supply and Delivery of Three (3) Units Tablets and Other Items (**Annex "A"**) with an Approved Budget for the Contract amounting to Eighty-Four Thousand Four Hundred Thirty-Two Pesos and 25/100 Only (₱83,432.25) which was included in the Final and Supplemental Annual Procurement Plan (APP) No. 4 and 6 for Fiscal Year 2021 (**Annex "B"**). The procurement opportunity is broken down into the following items:

WHEREAS, the mode of procurement is based on Item No. 8, Annex "H" of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, which provides that the Procuring Entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed One Million Pesos (₱1,000,000.00);

WHEREAS, on 16 June 2021, the BAC published the Request for Quotation (**Annex "C"**) and invited three (3) suppliers of known qualifications to participate in said procurement, namely: (1) Jassen Harris Industries Corp.; (2) Ace Electronic Technology, Inc.; and (3) Quadstar Digital Guidance, Inc.;

WHEREAS, the End-user forwarded to the BAC Secretariat its evaluation (**Annex "D"**) which found the offers of Avid Sales Corp. and ePartners Solutions, Inc., compliant with the eligibility requirements and specifications, which were verified by the BAC. Their quotations, with total amounts of Fifty-Six Thousand Five Hundred Thirty-Five Pesos Only (₱56,535.00) and Seventeen Thousand Six Hundred Ninety-Four Pesos Only (₱17,694.00), inclusive of all government taxes and fees, is deemed the most advantageous to the government, thereby making the same as;

- a) Avid Sales Corp. as the Lowest Calculated and Responsive Quotation for Item No. 1;
- b) Avid Sales Corp. as the Single Calculated and Responsive Quotation for Item No. 3; and
- c) ePartners Solutions, Inc. as the Lowest Calculated and Responsive Quotation for Item No. 2.

WHEREAS, the BAC finds the recommendation of the End-user in compliance with RA No. 9184 and its 2016 revised IRR; and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall, among other matters, recommend the award of contracts to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative.

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the Members of the BAC, hereby **RECOMMEND** to the HoPE the following:

- 1) **AWARD OF CONTRACT** via Small Value Procurement to **AVID SALES CORP.** for the **SUPPLY AND DELIVERY OF THREE (3) UNITS TABLETS AND SEVEN (7) UNITS WIRELESS BLUE-TOOTH NUMERIC KEYPAD** in the amount of **FIFTY-SIX THOUSAND FIVE HUNDRED THIRTY-FIVE PESOS ONLY (P56,535.00)**, inclusive of all appropriate taxes and fees;
- 2) **AWARD OF CONTRACT** via Small Value Procurement to **EPARTNERS SOLUTIONS, INC.** for the **SUPPLY AND DELIVERY OF TWO (2) UNITS LED MONITOR** in the amount of **SEVENTEEN THOUSAND SIX HUNDRED NINETY-FOUR PESOS ONLY (P17,694.00)**, inclusive of all appropriate taxes and fees;
- 3) **DECLARE** procurement failure for the Supply and Delivery of Two (2) Units Wireless Keyboard, due to the quotation received exceeds the Approved Budget for the Contract; and
- 4) **APPROVAL** of the foregoing result/s.
