- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Two Hundred Fourteen Thousand Three Hundred Seventy Eight Pesos Only (₱214,378.00) or such other sums as may be ascertained, Jassen Harris Industries Corp. agrees to provide the goods and services in accordance with his/her/its Bid.
