- 3. Sampling Requirements

- 3.3. Sample item/s must be submitted within seven (7) calendar days from issuance of Notice to Proceed (NTP).
- 3.4. A maximum of three (3) revisions to the sample shall be allowed, subject to the approval of the end-user.
- 4. Warranty
- 4.1. The supplier warrants that the items are free from defects in materials, workmanship, and design.
- 4.2. Any defective, damaged, incorrect, or disapproved item must be replaced immediately by the supplier at no additional cost to the procuring entity.
- 4.3. The supplier shall be responsible for retrieval and replacement of any defective or disapproved item and must ensure completion within three (3) calendar days upon notification.
- 4.4. Failure to replace or rectify the items within the specified period shall be subject to appropriate penalties as provided under existing procurement rules.
- 5. Payment and Delivery Terms
- 5.1. Delivery of Goods and/or performance of services shall be completed on or before 25 July 2025, at the location specified in the contract of purchase order.
