3.3. Delivery site is DOST-ASTI Bldg., UP Technology Park Complex, C.P. Garcia Avenue, Diliman, Quezon City.

4. GENERAL REQUIREMENTS

4.1. The Supplier shall provide materials, tools, labor and other necessary services and equipment required to complete the procurement project although not specifically mentioned in the specifications, working drawings, or in other contract documents without extra cost to DOST-ASTI.

4.2. Protect and maintain the required acceptable conditions of all repairs and accessories during construction until hand over.

4.3. All materials shall be subject to inspection and approval of DOST-ASTI prior installation.

4.4. Properly manage and dispose of all materials and waste generated during and after the project in accordance with local regulations.

5. SCOPE OF WORKS

5.1. The Supplier must conduct an ocular inspection before preparing their proposal. Any subsequent claims due to inadequate or inaccurate information will not be entertained.

5.2. Obtain the necessary permits to proceed with the project, including but not limited to building permits, electrical permits, and any other relevant local government permits.

5.3. Coordinate with MERALCO for the rehabilitation of the enclosures, including scheduling, technical requirements, and compliance with MERALCO standards and regulations.

5.4. Coordinate with ASTI regarding allowable downtime and downtime procedures during the works. The contractor must provide a temporary power supply to critical loads to ensure minimal interruption. This includes setting up and testing the temporary power supply system before commencing any work that requires power shutdown.

5.5. Dismantle two (2) existing cable gutters and two (2) vacant cable gutters. Ensure proper disposal of dismantled materials in accordance with environmental regulations.

5.6. Install two (2) new enclosures for the Transformer Load Side (lower) and MERALCO Breaker Line Side (upper).

5.6.1. Each enclosure must have dimensions of 1500mm (L) x 300mm (H) x 300mm (D).

5.6.2. Use NEMA 4X enclosures (Stainless Steel, 1.5mm thick).

5.6.3. Include padlock provisions for security.

5.6.4. Ensure proper grounding and bonding of the enclosures to meet safety standards.

5.7. Supply and deliver the enclosures during office hours, unless otherwise instructed by the end-user, to DOST-ASTI, Diliman, Quezon City for inspection by ASTI personnel/representatives. Ensure that all

GUIDELINES

A. Content and Format of Quotations

- 1. The Quotation/s must include the RFQ Number or the PR Number indicated above
- 2. Bidders must specify the BRAND NAMES and MODEL NAMES/NUMBER for the following goods:
 - a. Computer and electronic equipment and its accessories or peripherals
 - b. Software applications, programs, and digital licenses
 - c. Commercial off-the-shelf electronic devices or components
- 3. The Quotation/s must indicate the registered business name of the company (or individual), business address and contact number. It must also include the full name and signature of the company's authorized representative.
- 4. BIR Certificate of Registration for new DOST-ASTI suppliers.

B. Eligibiliy Requirements

Pursuant to Annex "H" or Consolidated Guidelines for the Alternative Methods of Procurement of the 2016 Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, the following documents shall be submitted except for Repeat Order, Shopping under Section 52.1(a), and Negotiated Procurement under Sections 53.1 (Two-Failed Biddings), and 53.5 (Agency-to-Agency):

For Procurement of Goods

- 1. Upon submission of quotation
 - a. Valid PhilGEPS Registration Number / Organization ID
 - b. Valid Mayor's/Business Permit
- 2. Upon issuance of Notice of Award (NOA)
 - a. Omnibus Sworn Statement (shall be required only for procurement projects with ABC above P50,000.00)
 - b. Income/Business Tax Return (For ABCs above P500,000.00)

For Procurement of Infrastructure

- 1. Upon submission of quotation
 - a. Valid PhilGEPS Registration Number / Organization ID
 - b. Valid Mayor's/Business Permit
 - c. Valid PCAB License

2. Upon issuance of NOA

- a. Omnibus Sworn Statement (shall be required only for procurement projects with ABC above P50,000.00)
- b. Income/Business Tax Return (For ABCs above P500,000.00)

*Requirements under Section 53.6 (Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services) of the revised IRR of RA No. 9184 will not apply to artists such as singer, performer, poet, writer, painter and sculptor who are engaged in business.

**Requirements under Section 53.10 (Lease of Real Property or Venue) of the revised IRR of RA No. 9184, specifically Mayor's/Business Permit, PhilGEPS Registration Number and Income/Business Tax Return will not apply to government agencies as lessors.

***For methods of procurement requiring Mayor's Permit and PhilGEPS Registration Number, valid Certificate of Platinum Membership may be submitted in lieu of the said documents.

C. Terms and Conditions

- 1. Additional requirements, if necessary, may be requested by the BAC depending on the item to be bid;
- 2. All transactions are subject to creditable withholding tax and final Value Added Tax or percentage tax per revenue regulation/s of the BIR;
- 3. Liquidated damages of at least equal to one-tenth of one percent (0.001) of the cost of the unperformed portion for every day of delay shall be imposed by the DOST-ASTI pursuant to Section 68 of the revised IRR of RA No. 9184; and
- 4. The DOST-ASTI reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
